Contributed funds are used to show bipartisan support of our friends in the Georgia legislature who champion the causes and concerns important to ophthalmology and medicine in our state.



GSO Foundation

The Georgia Society of Ophthalmology Foundation is a 501(c)(3) charitable organization whose mission is to support, promote, and develop projects and programs that raise awareness of and offer assistance to Georgians with ocular disease and conditions of the eye. Through the generous support of members, individuals, and commercial entities, the GSO Foundation funds projects that support underserved populations and address unmet needs related to eye health and access to care in Georgia.



SOS Legal & Advocacy Fund

The SOS Legal & Advocacy Fund is an expansion of the Legal Defense Fund (LDF), which was created as a rainy-day fund to pay for legal representation if legal issues over the practice of ophthalmology arise. After the events of the 2017 legislative session, the Council realized there are broader and immediate concerns requiring financial attention—and therefore decided to expand and re-brand the LDF to also include advocacy funding, hence the new name. For GSO, SOS stands for Safe Ophthalmic Surgery.


The Georgia Society of Ophthalmology must ensure balance, independence, objectivity, and scientific rigor in all our sponsored educational activities. In accordance with the Essential Areas and Standards for Commercial Support of the Accreditation Council for Continuing Medical Education (ACCME), faculty members must disclose relationships with a commercial interest if:

(a) the relationship is of a financial nature and occurred within the past twelve (12) months AND (b) the individual has the opportunity to affect the content of CME with regard to the products or services of that commercial interest.

ACCME has not set a minimum dollar amount defining relationships considered to be significant. Inherent in any amount is the incentive to maintain or increase the value of the relationship. ACCME considers relevant financial relationships of a spouse or partner to be significant and requires them to be disclosed.







Biography

Zaina Al-Mohtaseb, MD is an ophthalmologist specializing in cornea, external disease, cataract and refractive surgery. Dr. Al-Mohtaseb earned her medical degree with honors from Baylor College of Medicine. She completed her ophthalmology residency at the Cullen Eye Institute at Baylor College of Medicine and was elected Chief Resident. She finished her training at the University of Miami's Bascom Palmer Eye Institute with a fellowship in cornea/external disease, cataract & refractive surgery.

She has authored more than 40 peer reviewed scientific publications and book chapters and is an active peer-reviewer. She has taken an active leadership role and presents at multiple national and international conferences and has become a key opinion leader in ophthalmology. She truly enjoys education and is currently the associate residency director at BCM and involved heavily with ASCRS Young Eye Surgeon committee.

Biography

Sophie J. Bakri, MD is Chair and Professor of Ophthalmology at Mayo Clinic, Rochester, MN. She holds the Whitney and Betty MacMillan Professorship in Ophthalmology in Honor of Robert R. Waller, MD. Dr. Bakri is a specialist in diseases and surgery of the retina and vitreous, in particular, age-related macular degeneration, diabetic retinopathy, and repair of complex retinal detachments. She undertakes both clinical and translational research in the pathogenesis and treatment of retinal diseases. She has served as Director of the Medical and Surgical Retina Fellowships at Mayo Clinic.

Dr. Bakri completed a vitreoretinal surgery fellowship at the Cleveland Clinic Foundation and her residency at Albany Medical College, New York. She graduated from the University of Nottingham Medical School, England. She holds an MBA from the Wharton School, University of Pennsylvania. She has authored over 230 peer-reviewed papers and 26 book chapters on retinal diseases. She is a principal investigator on numerous multicenter clinical trials on novel drugs for retinal disease. She is the Editor-in-Chief of the book Mayo Clinic on Vision and Eye Health, and is on the Editorial Board of the American Journal of Ophthalmology, Retina, Seminars in Ophthalmology and OSLI Retina.

She is an active participant in several ophthalmic societies. She has served the Macula Society as Meeting Planning Chair and as an Executive Committee member, the American Society of Retinal Specialists as a Board member and member of the Program Committee. She is a member of the Retina Society, serving on the Nominating Committee. She has served the American Academy of Ophthalmology on several committees.

She has received numerous awards, including the Ophthalmologist Top 40 under 40 award, a Senior Achievement Award from the American Academy of Ophthalmology, a Senior Honor Award from the American Society of Retina Specialists and inducted into the Retina Hall of Fame. She has also been honored with receiving the Young Investigator Award from the American Society of Retina Specialists.




Arpita Bhasin, MD, PhD

Board certified in the U.S and Canada, Vivek R. Patel, MD, is Professor of Clinical Ophthalmology and serves as Chief of Neuro-Ophthalmology at the University of California, Irvine. His clinical practice is dedicated to the medical and surgical management of adult strabismus, and the full spectrum of neuro-ophthalmologic disorders. His research interests include studying structural and functional changes in the visual pathways following retinal and optic nerve injury, using diffusion tensor tractography and functional MRI techniques; as a Principal Investigator for this work, his team has been continuously funded by the NEI-NIH over the past 5 years.

Dr. Patel is a dedicated educator, having served as Ophthalmology Residency Director, Neuro-Ophthalmology Fellowship Program Director, and has been recognized as Teacher of the Year 8 times in his career thus far. He is an Associate Editor for the Journal of Neuro-Ophthalmology and co-author of the 3rd and 4th editions of Walsh & Hoyt's Clinical Neuro-Ophthalmology: The Essentials, which is considered one of the central textbooks of neuro-ophthalmology.

He has published extensively in the peer reviewed literature and is the Chief Medical Editor of Glaucoma Physician.

Dr. Neda Shamie is a renowned cataract, LASIK and corneal surgeon and partner of the Maloney-Shamie Vision Institute in Los Angeles. Prior to joining Dr. Maloney, Dr. Shamie was the Medical Director of the Doheny Eye Institute in Beverly Hills and is a Clinical Associate Professor of Ophthalmology at the USC Keck School of Medicine.

Recognized as an expert in complex vision correction surgery, Dr. Shamie performs the full spectrum of procedures including advanced lens laser cataract surgery, iDesign LASIK & PRK, DSEK & DMEK, and Collagen Cross-Linking. Dr. Shamie has co-authored over 50 publications on the topics of cataract surgery and corneal transplantation, written 8 chapters for surgical textbooks and has led international lectures, courses, and seminars teaching colleagues about the advances in vision correction surgery.

She was the first surgeon in the Northwest to offer artificial corneal transplantation to patients as well as DMEK surgery. She is an active member of numerous ophthalmic societies, has served on the Cornea Clinical Committee of the American Society of Cataract and Refractive Surgery.

Associate Professor of Ophthalmology





John Kim, MD


